# Butler County Board of Elections Board Meeting Minutes September 11, 2017

The Butler County Board of Elections met on Monday, September 11, 2017, at 9:05 a.m. for a regular meeting. Roll call was taken and present were Member Kathy Wyenandt, Member Todd Hall, Member Chris Wunnenberg, Deputy Director Jocelyn Bucaro and Early Voting Administrator Eric Corbin. Member Wyenandt is acting Chairman.

Member Wyenandt submitted the minutes from the August 21, 2017 regular meeting for approval. Member Hall moved to approve the minutes for August 21, 2017; seconded by Member Wunnenberg. Roll call:

Member Wyenandt submitted the minutes from the August 29, 2017 special meeting for approval. Member Hall moved to approve the minutes for August 29, 2017; seconded by Member Wunnenberg. Roll call:

Director Noonan acknowledged receipt of Directive 2017-18 Ballots for November 7, 2017 General Election.

Under Election Business Director Noonan submitted the Precinct Election Officials to be appointed to the 2017-2018 term per R.C. 3501.22(A). Director Noonan stated 1,158 workers have been placed. Member Hall asked how many workers are needed. Director Noonan answered 1,128 are required. Member Hall asked how the precinct election officials were recruited. Director Noonan explained the workers were recruited through previous workers, Facebook, Church bulletins, newspapers, utility bill inserts, and other methods.

Member Hall asked if the office tracks how the workers are recruited. Director Noonan explained the office creates a report after each election so resources can be focused on finding the most qualified election officials. Member Wunnenberg moved to appoint the Precinct Election Officials to the 2017-2018 term; seconded by Member Hall. Roll call:

Under New Business, Director Noonan presented the 2018 Budget for review and approval. She explained that the budget is based on the last like election year, 2014. She noted that there is \$4,000,000 in the budget for capital equipment and wanted the Commissioners to be aware of the need if they choose to remove the money from the budget. Member Wunnenberg said the Commissioners could pass a new resolution to appropriate the funds if they are not in the budget. For clarification, Member Wyenandt asked if Member Wunnenberg thought the budget should include the money for capital equipment. Member Wunnenberg said it is not necessary to keep the capital equipment in the budget because the Commissioners are going to remove it and can appropriate the money later. Member Wyenandt asked if the capital equipment line is removed from the budget, what other lines will be affected? Director Noonan and Deputy Director Bucaro indicated the other lines would not be affected. Member Wunnenberg moved to approve the 2018 Budget with the removal of the \$4,000,000 for capital equipment; seconded by Member Hall. Roll call:

Director Noonan submitted the precinct changes in the City of Trenton. She explained there are voters who reside in the City of Trenton and the surrounding township. Member Hall asked if the office has all the supporting documentation. Director Noonan said yes, the office has all the documentation to make these changes. Deputy Director Bucaro explained that when the City of Trenton annexed these parcels, the township boundaries were not

adjusted by the Commissioners. Member Hall moved to approve the precinct changes; seconded by member Wunnenberg. Roll call:

Under the Director's Report, Director Noonan thanked everyone for being supportive during her recent illness. She said the poll worker department is on the way to its goal of 1,400 election workers and that the temporary staff is doing a great job.

Under the Deputy Director's Report, Deputy Director Bucaro told the Board that the mock election for the new electronic poll books went very well. After training one group of workers set up their polling location in the conference room in the Board of Elections Building while the other group went out to Reily Township, a location with a weak cell phone signal. The workers were paid \$100 for their time, about six hours, two of which were spent in training. Deputy Director Bucaro added that poll worker training materials were submitted to the state on time. She also said Train the Trainer classes are starting on October 3, 2017 and that all trainers have been asked to attend the first day so they have time to learn the system before having to teach others. She confirmed ballots were posted in accordance with state requirements and more proofing is happening now. Military and overseas ballots are on track to be mailed out by the September 23, 2017 deadline. Deputy Director Bucaro indicated a press release will be issued. She then passed out the 2017 November Pre-Election Profile. Member Hall asked where this data is available. Deputy Director Bucaro said it is posted to our website. Member Hall suggested getting the information out to average voters. Deputy Director Bucaro explained Early Voting Administrator Corbin is working on a flyer that will be printed on colored paper to help voters complete their ballots and identification envelopes correctly. Data will be collected to see if there is a reduction in errors after the flyer is introduced.














