Deputy Director Bucaro informed the Board they could bring up any other issues for consideration if desired. St. Clair Township Fiscal Officer Douglas Wheelwright shared a letter with the Board explaining that when the correcting resolution was ready for his signature he was not in town to sign the document. He gave the township solicitor authority to sign the correcting resolution via text message. He explained how important this levy is to the constituency of St. Clair Township and that he had signed the original resolutions attempting to place a levy on the ballot.

Member Wunnenberg asked when the deadline was to file resolutions. Deputy Director Bucaro stated August 9, 2017. Member Hall asked Wheelwright about St. Clair Township's staff. Wheelwright explained, excluding the road crew, he and one office administrator are the entire staff. Member Wunnenberg asked what the first error was that caused the issue. Deputy Director Bucaro explained that the township did not correctly specify which year the tax would begin to be collected. Wheelwright clarified that the issue is a renewal and indicated the tax year to collect would be the one following the last year included when the issue was on the ballot last. Deputy Director Bucaro noted the prosecutor's office advised that the tax collection year could not be determined by the Board.

St. Clair Township Solicitor Gary Sheets addressed the Board. He explained that, although the tax collection year in the resolution is incorrect, the accompanying Auditor's Certificate provides calculations for the correct taxing year, and therefore the intent of the township is clear. Member Wunnenberg stated that it is important the people of St. Clair Township have the opportunity to vote on the issue and the paperwork should have been correct. Member Wunnenberg moved to certify the St. Clair Township EMS Levy to the November 7, 2017 General Election; seconded by Member Hall. Roll call:
