Director Noonan acknowledged receipt of Directive 2017-19, Reminder of Important Security Precautions and Practices, Advisory 2017-08, Cybersecurity Training Opportunity, and Memorandum 2017-01, Special Powers and Responsibilities of Sheriffs on Election Day – November 7, 2017.

Under Election Business, Director Noonan stated that in the November 2015 General Election at this point in time, 1,390 vote-by-mail ballots had been issued. This year 2,648 vote-by-mail ballots have been issued, an increase of ninety percent. This is mainly due to a special interest group mailing that sent applications to many voters in Butler County. Member Wyenandt asked if most of the rejected applications are due to not being registered. Director Noonan explained not being registered is one reason, as well as not signing, or completing the application properly. Deputy Director Bucaro added that when an application is rejected by our office, the voter is notified to correct the application.

Under Old Business, Director Noonan presented the 2018 budget totaling \$3,376,428.48, including an additional \$90,000 for the Hardware Maintenance Agreement as well as \$9,000.00, for onsite election day support for two elections. Deputy Director Bucaro pointed out that the County Finance Director is recommending cuts including \$31,872.00 in postage, \$10,000.00 in unemployment, \$8,000.00 in travel and training. Director Noonan expressed her concern with the postage cut specifically. Deputy Director Bucaro explained the postage was reduced to the amount used in 2010. She added, since 2010, we have 15,000 more voters and that in 2014 voter turnout was lower than 2010 but vote-by-mail was higher creating more need for postage money in 2018 than 2010. The travel and training budget is also cut \$8,000.00 from \$15,000.00, which is lower than what was appropriated for 2017 and less than the \$15,000.00 that was spent this year. Director Noonan and Deputy Director Bucaro are going

through Election Center coursework for national certification and Deputy Director Bucaro is set to graduate next year if the office can send her to the last set of classes. All of the Board Members and most of the staff are going to the January conference, which would use up most of the travel and training budget.

Member Wunnenberg asked if \$95,000.00 was spent on postage in 2015. Deputy Director Bucaro explained that the 2016 postage was distributed across two years. She also added that the office is now required to do an annual National Change of Address mailing that was not required in even years before. The Board Members agreed with the Directors' assessment that the postage budget should not be reduced and would ask that the travel and training budget not be reduced below the \$10,000.00 appropriated in 2017.

Under New Business, Director Noonan reviewed the list of withdrawals from the Ohio Election Commission. Member Hall moved to withdraw the complaints; seconded by Member Wyenandt. Roll call:

Under the Director's Report, Director Noonan stated the office has trained 577 poll workers, with 949 to be trained in the next week and a half. Member Hall asked who is training the poll workers. Deputy Director Bucaro said temporary staff. Director Noonan provided a report showing the number of new workers recruited from different source. She explained 26 new poll workers signed up at the Middletown Night Out event, 36 from Facebook ads and 71 new poll workers from inserting flyers in Hamilton utility bills. Member Hall asked if there was a cost analysis. Member Wyenandt noted that according to the bills document, the Facebook ads cost \$394.18 for two weeks of advertisements. Member Wyenandt added, according to the bills document, 28,000 recruiting flyers inserted with electric bills cost \$196.00. Member Hall asked what exactly it means that 306 poll workers were recruited from schools. Director Noonan explained that Community Outreach Coordinator Tammy Cuevas has gone to every high school in Butler County to speak with some classes and meet with some school officials, as well as hanging posters. Member Hall asked how much the school outreach cost the office. Director Noonan said she did not have a total number but it would be the cost of the posters, Tammy's time and mileage.

Director Noonan reported that Dominion removed the \$8,000.00 charge to renew the Hardware Maintenance Agreement.

Under the Deputy Director's Report, Deputy Director Bucaro, noted that we are evaluating each poll worker in training to ensure the best people are placed in the field. We are able to do this because we had such a successful recruitment effort, recruiting 2,400 poll workers when only 1,100 are needed. She reported that logic and accuracy testing is just about finished and should be completed tomorrow. She explained that Jay is tracking the number of voter access cards that are failing in testing and noted that we may need to purchase more before next year's elections.

With no further business, Member Hall moved to adjourn; seconded by Member Wyenandt.
