Butler County Board of Elections Board Meeting Minutes May 2, 2023

The Butler County Board of Elections met on Tuesday, May 2, 2023, at 6:30 a.m., for the Special Election. Roll call was taken, and present were Chairman Frank Cloud, Member mariann penska, Member Todd Hall, Member Chris Wunnenberg, Director Nicole Unzicker, Deputy Director Eric Corbin, Early Voting Administrator Stephanie Webb, and Poll Worker Administrator/Executive Assistant Melissa Trotta.

At 6:30 a.m. the Board met to order the polls opening for the May 2, 2023 Special Election.

Director Unzicker presented Document 1, Records Retention Schedule. Director Unzicker stated the board updated the retention schedule to include the ballot box retention. Director Unzicker explained the document includes the Ohio Secretary of State retention schedule and the Board of Elections schedule. Director Unzicker stated other updates include adding electronic records to media type. Member penska moved to approve the Records Retention Schedule as listed in Document 1; seconded by Member Hall. Chairman Cloud ask if there were any comments or questions. Member Wunnenberg asked about the records with the retention period of "until no longer administrative value." Director Unzicker stated Deputy Director Corbin and herself spoke with the County Prosecutor regarding transient correspondence. She said the County Prosecutor suggested using the above retention period for transient correspondence, as in call logs, notes, other notices etc. Member penska asked how the retention schedule affects public requests. Director Unzicker explained public record requests will be fulfilled according to the retention schedule, if the retention schedule has been met, the requestor will be notified that there are no corresponding records.
