Under New Business, Director Unzicker presented Document 3, Validate and Invalidate Provisional Ballots Cast in the May 2, 2023, Special Election. Director Unzicker stated there are a total of 55 valid provisional ballots, and 27 invalid provisional ballots. She presented the following invalid ballots, 10 provisional ballots are invalid because the voters were not registered to vote in Ohio, 16 provisional ballots that are invalid because of identification, and 1 provisional ballot is invalid because the voter cast their ballot at the wrong polling location. Director Unzicker explained the 16 provisional ballots that were invalid because of identification was due to the voter not checking the box verifying they had shown valid identification to the pollworker. Director Unzicker stated the e-poll books were also used to verify that the voter did not show identification. Member penska asked if voters could cure their ballot. Director Unzicker said yes, the voter had until Saturday, May 4, 2023, to come to the board to provide valid identification. All board members reviewed the 16 ballots. There was a short discussion regarding the new identification requirements for provisional ballots. Member Wunnenberg made a motion to approve the 55 valid provisional ballots and to invalidate the 27 invalid ballots; seconded by Member Wunnenberg. Roll Call:
