Deputy Director Corbin presented Document 4, Reject Insuffucient Candidate Petitions to the the November 7, 2023, General Election. Deputy Director Corbin stated the candidates have failed to meet the statutory requirements to appear on the ballot for the reasons listed. Member Hall moved to reject the candidates to the November 7, 2023, General Election as listed on Document 4; seconded by Member Wunnenberg. Member penska asked if there were any comments or questions. Member Hall asked if the candidates had been notified. Deputy Director Corbin stated the candidates would be notified that they were not certified to the ballot and would be given the opportunity to request a reconsideration hearing. Member Wunnenberg clarified that Mr. Elijah Beeler was notified on June 1, 2023, of the deficiencies on the petitions. Deputy Director Corbin confirmed Member Wunnenberg's addition. Director Unzicker explained that the Candidate & Ballot Services department notifies candidates if there is time to withdraw insufficient petitions and file new ones before the filing deadline. Deputy Director Corbin stated the remaining candidates filed closer to the filing deadline and did not have the same opportunity. Roll Call:

The following candidates failed to meet the statutory requirements to appear on the ballot for the reasons stated below. Unless indicated otherwise below, the Board hereby rejects these petitions for certification for the ballot.

# Rejected My 8-16-33

### John P. Centers – Monroe City Council

- The new petition fails to state how many signatures the circulator witnessed as the circulator in the Circulator's Statement as required under R.C. 3501.38(E) in part-petition 4, rendering it and its 18 signatures invalid.
  - Number of valid signatures required 50
  - Number of signatures submitted 69
  - Number of valid signatures left due to invalid part-petition 39

### Christina McElfresh – Monroe City Council

- Due to a number of voters printing their signatures and other reasons, the candidate lacks sufficient
  - valid signatures for the petition to be certified for the ballot.
    - Number of valid signatures required 50
    - Number of signatures submitted 58
    - Number of valid signatures left due to invalid part-petition 47

### Elijah Beeler – Trenton City Council

- Candidate pulled petitions with CBS staff on February 22, 2023. Among the documents the candidate signed during that meeting, he acknowledged receiving a written copy of rules regarding petitions among which one states: "[a]fter finishing a petition sheet, the circulator must sign and fully complete the circulator's statement ..." On June 1<sup>st</sup>, the candidate filed the petitions before the Board.
- None of the three part-petitions filed by the candidate have a completed or signed Circulator's Statement as required under R.C. 3501.38(E). This is a statutory requirement for all candidate petitions to be valid.
- Candidate was informed of this deficiency by CBS staff on June 1<sup>st</sup> by telephone after he left the office
  after filing and of his right to withdraw consideration of this filing so he may file a new petition before
  the filing deadline on August 8<sup>th</sup>. Candidate never filed to withdraw consideration of this petition to file
  new petitions for the Board's consideration.

### Sue Hensley – Village of Millville

- During the midafternoon hours of August 8<sup>th</sup>, the candidate filed a written withdrawal of consideration
  of a previous filed patition due to defect in it and filed a new patition. Before scenting the files. POF
- of a previous filed petition due to defects in it and filed a new petition. Before accepting the filing, BOE staff gave the candidate a pre-filing checklist typically given to candidates when they pull their petitions,

and the candidate was given time to review their filing with the checklist before filing. After reviewing the checklist and her filing, the candidate indicated she was ready to proceed with filing her withdrawal of the prior petition and filing of a new petition.

 The new petition fails to state which office in the Village of Millville the candidate is seeking (there are at least two possibilities), as well as the date of the election, the entire Nominating Petition section and how many signatures the candidate witnessed as the circulator in the Circulator's Statement as required under R.C. 3501.38(E).

### Jewel Hayes Hensley – Village of New Miami Mayor

- BOE staff review found that of the 84 signatures submitted, 20 were invalid because the signer was not
  registered to vote, another 3 were not registered at the address they listed in the petition, 8 signers live
  outside of the village, and another 10 had signatures that staff could not sufficiently match with the
  signatures on file for that voter. As such and for additional reasons, the candidate's petition is invalid
  for lacking sufficient signatures to qualify for the ballot.
  - Number of valid signatures required 50
  - Number of signatures submitted 84
  - Number of valid signatures 40

### Terisa Huckleby Couch – Village of New Miami Council

- BOE staff review found that of the 62 signatures submitted, 18 were invalid because the signer was not
  registered to vote, another 1 was not registered at the address they listed in the petition, 3 signers live
  outside of the village, and another 5 had signatures that staff could not sufficiently match with the
  signatures on file for that voter. As such and for additional reasons, the candidate's petition is invalid
  for lacking sufficient signatures to qualify for the ballot.

  - Number of signatures submitted 62
  - Number of valid signatures 33
