The following candidate failed to meet the statutory requirements to appear on the ballot for the reasons stated below. Unless indicated otherwise below, the Board hereby rejects the petition for certification for the ballot

Rejected MJ 8 49.13

Brian J. Hill - Ross Local School Board

- · The petition filing consists of one petition sheet of the required Statement of Candidacy and Nomination Petition section along with three voter signatures, a separate page of twenty voter signatures and a third page consisting of seventeen voter signatures and a signed circulator's statement by the candidate indicating he had witnessed 40 signatures for his petition. Together, the three pages have 40 signatures.
- R.C. 3513.261 states: "If the petition consists of more than one separate petition paper, the statement of candidacy of the candidate or joint candidates named need be signed by the candidate or joint candidates on only one of such separate petition papers, but the statement of candidacy so signed shall be copied on each other separate petition paper before the signatures of electors are placed on it" (emphasis added).
- In State, ex rel. Maras v. LaRose (2022), 167 Ohio St.3d 144, 2022-Ohio-866, ¶ 22, the Ohio Supreme Court stated: "R.C. 3513.09 is unambiguous: if a petition consists of more than one part-petition, then the declaration of candidacy 'shall be copied on each other separate petition paper before the signature[s] of electors are placed on it.' Plainly, Maras did not comply with this requirement: the declaration was not 'copied on' the Maras part-petition forms before or after the signatures were
- The Court upheld the denial of certification of the candidate for the ballot for not having a copy of the signed statement of candidacy for each signature page stating that "[s]ubstantial compliance does not contemplate complete omission." (Citing State, ex rel. Weller v. Tuscarawas County Board of Elections (2019), 158 Ohio St. 3d 266, 2019-Ohio-4300, ¶ 12.)
- Based on the foregoing, it would appear the failure of the petition to have a separate individual copy of the signed statement of candidacy accompanying each voter signature page violates the statutory requirements of a valid candidate petition under R.C. 3513.261 under Ohio Supreme Court precedent.

Document 6

Deputy Director Corbin presented Document 7, Ballot Issue in Question. Deputy Director Corbin stated the document outlines the issues found by the County Prosecutor's office. He said representatives for the village are attending the meeting. Solicitor for Village of Millville Harrison Green stated the Village worked with Butler County Prosecutor's office on the ballot issue. He said the language was written twice, approved by the prosecutor, and passed by twice the village council members three times. Chairman Cloud asked Deputy Director Corbin if the board had spoken to the prosecutor's office. Deputy Director Corbin stated yes. Deputy Director Corbin explained one of the issues is the language in the second resolution to proceed was not the same language as stated in the first resolution. Member Wunnenberg asked who created the document. Deputy Director Corbin said the document is a summary from the Prosecutor's office. Member Wunnenberg asked Mr. Green if the Prosecutor approved the issue. Mr. Green stated the Prosecutor approved it the first time but was told later that the language needed to be updated due to the changes in the Ohio Revised Code. Member Penska asked if the new resolutions were passed in the three council meetings. Mr. Green stated both languages were passed in three council meetings. Deputy Director Corbin stated with the new laws, there has been several localities with issues in regard to how millages are formatted. Chairman Cloud asked when the filing deadline was to approve the ballot issue. Deputy Director Corbin said that there was not a set date. Member Wunnenberg asked which resolution they would certify if the board chooses to certify the ballot issue. Deputy Director Corbin stated that if the board certified the issue, the Prosecutor's instructions were to use the same purpose originally on the ballot. Ballot Issues

The following proposed ballot issue has the following identified deficiencies which may prevent it from being certified for the ballot.

WY 8/4/4/

Village of Millville (Renewal) - Fire - 2.75 mills / 5 years

- The resolution to proceed has a blank number in the "Adopted" section indicating the number of meetings the resolution received before being adopted. Given the dates of the other documents, it is unlikely the resolution was passed in regular order in three readings over three separate meetings. However, the resolution does not state, nor do any other documents filed by the village indicate, that the resolution to proceed was passed as an emergency measure such that it could pass with one reading in a single meeting. Therefore, there is a question whether this resolution was passed in compliance with Ohio law to be legally effective under R.C. 731.17(A)(2).
- The language for the purpose of the levy as stated in the second resolution is not the same as stated in its own Exhibit A or as stated in the first resolution.
- The second resolution, the resolution to proceed, omits a reference to the section of the Revised Code authorizing a property tax levy for the stated purpose. It is stated in the first resolution and it is unclear whether the Ohio Revised Code requires it be stated in the second resolution although it customarily is.
- Neither resolution clearly states whether it is to be presented to the entire territory of the village or
 just a portion as required under R.C. 5705.03(B)(1)(g). This item is not clearly required by the Revised
 Code, but it is highly relevant as it aids the Board of Election in providing clear direction to ensure
 ballot issues appear on the correct precinct and split precinct ballots.

Director Unzicker presented Document 10, Public Terminal for Signature Verification. Director Unzicker stated the County Board of Elections is prohibited from pre-checking signatures. She explained the service was offered in the past. Director Unzicker stated once the board received a security directive set forth by the Ohio Secretary of State (SOS), the public terminal was removed in January 2020. She said the board has been working with the Secretary of State's Office, Butler County Information Technology Services department, and Board of Elections Database Administrators to see if there is a way to secure a public terminal while complying with the security directive. Director Unzicker stated one of the main issues is sharing passwords to log into the terminal. She said the security directive prohibits sharing passwords, so one employee would have to be assigned the multi-factor token and that they would have to be available when the candidate or members of the public come in to verify the signatures. There was further discussion about one employee being available, procedures and access for candidates or members of public, and what voter information would be available. Member penska requested additional information regarding security assurance.n
