Post-Election Audit Summary

March 17, 2020 Primary Election

Audited Races:

Delegates-at-Large and Alternates-at-Large to the National Convention Democratic Delegate Representative to Congress (8th District) Democratic Party Judge of the Court of Appeals (12th District) Republican Party

Beginning on May 27, 2020, the Butler County Board of Elections conducted an audit of the March Primary Election. Per the Secretary of State, the audit was conducted on the "top of the ticket" contest on the Democratic ballot and two countywide contests. The Butler County Board of Elections chose the above-mentioned races to audit.

The Board selected to use polling locations as the unit to be audited. A total of 46,454 votes were cast in Butler County in the March 2020 Primary Election, a turnout of 18.8%. In the 3 races to be audited, 57,516 votes were cast. A spreadsheet was used to record the results of the audit, which must find an accuracy rate of 99.5 percent or greater. The Board randomly selected units to be audited until at least 5 percent of the votes cast or (2,323) were included in the ballots to be hand counted. A total of 5 polling locations were randomly drawn, containing 14 precincts, for a total of 2,486 ballots.

All the ballots from the selected precincts were gathered by type and counted manually. Three discrepancies were found after hand counting those 2,486 ballots. The total cost to conduct the audit, excluding regular staff pay, was \$192.50.

The results of the audit by contest are outlined below.
