HAMILTON, OH: The Butler County Board of Elections will be open for early voting beginning Tuesday, October 8, 2019, at 8:00 a.m. for voters wishing to vote in person prior to the

General Election on November 5, 2019.

The Board will be open for in-person early voting during the following hours:

Week 1: October 8 - October 11

8:00 a.m. to 5:00 p.m. on each weekday (Tuesday through Friday)

Week 2: October 14 - October 18

8:00 a.m. to 5:00 p.m. on each weekday (Tuesday through Friday) *October 14th Early Voting is closed in observance of Columbus Day.

Week 3: October 21 - October 25

8:00 a.m. to 5:00 p.m. on each weekday (Monday through Friday)

Week 4: October 28 - November 3

8:00 a.m. to 7:00 p.m. on each weekday (Monday through Friday)

8:00 a.m. to 4:00 p.m. on Saturday, November 2nd

1:00 p.m. to 5:00 p.m. on Sunday, November 3rd

Week of Election Day: Monday, November 4th

8:00 a.m to 2:00 p.m. on Monday, November 4th

Complete and send an application by noon on Saturday, November 2, 2019. An application may be downloaded from our website: elections.bcohio.us, or voters may call the Board of Elections to request an application at (513) 887-3700.

Mail your application or letter requesting a ballot to:

Voter's written request for a vote-by-mail ballot MUST include the following information:

- Name and current address
- Date of Birth
- Mailing address for the ballot, if different than current address
- **One Form** of Identification:
 - o last four digits of your social security number
 - o driver's license number
 - o copy of a current and valid photo ID
 - o current utility bill (including cell phone bill)
 - o bank statement
 - o government check
 - o paycheck
 - Other government document that includes the voter's name and address
- The Election in which you intend to vote and the election date (November 5, 2019)
- A statement indicating the voter is a qualified elector
- Voter's signature

Ballots returned by mail must be postmarked no later than Monday, November 4, 2019, and must be received by the Board of Elections no later than Friday, November 15, 2019, ten (10) days after the election. Ballots may be delivered in person by the voter or voter's family member to the Board office by close of polls (7:30 p.m.) on Election Day.

Voters with a qualifying disability under the Americans with Disabilities Act (ADA) may request an accessible ballot by filling out Secretary of State form 11-G.

If a voter or voter's minor child is hospitalized due to a medical emergency on Election Day, you should contact the Board of Elections. Voters with such an emergency may apply for an absentee ballot until 3:00 p.m. on Election Day.

Vote by mail ballots may **not** be returned to a polling location on Election Day.



Out-of-country Civilian and Uniformed Armed Service ballots must be received by the Board of Elections by Friday, November 15, 2019, ten (10) days after the election to be counted.
